It is also mutually agreed that the following terms of the agreement form an integral part of this contract and that no variation or modification of this contract shall be effective unless accepted by The Photographers in writing.

Booking Fee - A booking fee deposit is charged when The Client signs this contract. This fee is deducted (in full) from the TOTAL price on completion of the contract.

Payments - The Balance of fees due, are to be paid 28 days before the wedding day. Payment of additional photographs to be made when these are ordered.

Display - I hereby allow the photographer to display any photograph included in this contract in his studio or portfolio. No use of the photographs will be made by the photographer for other commercial reasons, except with the permission of the customer in writing.

Photographers - All photograph sizes are approximate. The photographers will provide a pleasing colour balance but cannot guarantee exact colour matching. Owing to anomalous reflectance caused by a combination of certain dyes and materials, especially man made fibres, it is sometimes impossible to record on film the exact colour of materials as seen by the human eye

Re-orders - All re-orders shall be treated as an extension of this contract. No responsibility for error will be accepted unless orders are given in writing.

Copyrights - The 1988 Copyright Act assigns the copyright to the Photographer. It is contrary to the Act to copy or allow to be copied, any photographs covered by this contract. The copyright will be retained by Nigel Barrett Photography.

Licence - The Photographers shall be granted artistic licence in relation to the poses photographed and the location used. The Photographers' judgments regarding the locations, poses and number of photographs taken shall be deemed correct.

Prices - All services and/or goods are supplied at the prices ruling at the time of supply and are subject to VAT at the current rate(s).

Force Majeure - The due performance of this contract is subject to alteration or cancellation by The Photographers owing to any cause beyond their control. In the unlikely event of total photographic failure or cancellation of this contract by The Photographers liability shall be limited to a full refund of all monies paid.

Photographers - When a particular photographer is requested, we are usually able to oblige, however we are unable to guarantee named photographers due to holidays, sickness etc.

Cancellation - Cancellation will result in the loss of any deposit paid.

The Customer(s) may cancel this contract at any time by giving written notice to Nigel Barrett Photography

Cancellation charges are as follows:

1. More than ninety days prior to the date - deposit only.
2. Ninety days to thirty days prior to the date - deposit plus half the remaining cost.
3. Less than thirty days prior to the date - full amount.
